SCOPE: All potential collectors and technical staff involved with blood banking protocols.

PROCEDURE:

- I. CRITERIA REQUIRING SECOND SAMPLE COLLECTION:
 - A. All patients with an order for a crossmatch and they have no previous blood bank history and the sample was not collected using a positive ID system such as barcode technology.
 - B. All patients with an order for a type and screen (with the potential to receive blood products) and they have no previous blood bank history and the sample was not collected using a positive ID system such as barcode technology.
- II. PATIENTS THAT ARE EXEMPT FROM SECOND SAMPLE COLLECTION:
 - A. Patients with a previous blood bank history
 - B. Trauma patients
 - C. OR patients
 - D. Patients requiring blood on an emergency basis
 - E. Patients with an ABO/Rh order only
 - F. Patients with an order for a Type and Screen only that are not going to receive blood
 - G. Patients with samples that were collected using a positive ID system such as barcode technology

III. REQUIREMENTS:

- A. If a second sample is required it is the responsibility of the blood bank tech to order it by placing an "Y" in the ABO/Rh second sample result screen in the computer.
- B. At times when a second sample is impossible to obtain or due to the patients immediate condition, a previously collected sample may be used for second sample

ABO/Rh testing (CBC tube). This tube MUST have been collected at a time other than the time of the original blood bank tube and prior to blood being transfused. It is the responsibility of the blood bank tech to determine if the sample is usable.
