SCOPE: All potential collectors and submitters of cytology samples for testing.

I) **PROCEDURE**:

- A) **FIXATION OF SPECIMENS** All specimens must be submitted properly, fixed or fresh, as outlined below:
 - 1) <u>Body Cavity Fluids</u> submitted fresh with the addition of CytoLyt solution upon receipt in the laboratory.
 - 2) <u>Brushings</u> submitted in CytoLyt solution.
 - 3) <u>Washings and Lavage</u> submitted fresh; with CytoLyt solution to be added upon receipt in laboratory.
 - 4) <u>Scraping Smears</u> submitted in CytoLyt solution.
 - 5) <u>FNA's</u> smears fixed in 95% ethanol or air dried; needle and syringe flushings in CytoLyt solution; core biopsies in formalin; for flow cytometry in transport media (in lab); other testing (amylase, CEA etc.) in conical tube or sterile container.
 - 6) <u>Sputums</u> submitted in CytoLyt solution (preferred) or specimen cup.
 - 7) ThinPrep Pap specimens PreservCyt solution.
 - 8) <u>Urines</u> voided urine, catheterized urine and bladder washings submitted fresh with the addition of CytoLyt solution upon receipt in the laboratory.
- B) The following is a list of submission procedural details which may lead to rejection of a cytology specimen.
 - 1) IMPROPER DOCUMENTATION
 - (a) Discrepant or lack of patient demographics on container.
 - (b) No specimen submitted but orders received.
 - (c) Lack of the following desirable information after documented efforts have been made to contact the clinician and obtain such information may result in rejection
 - (i) Patient's full name
 - (ii) Chart number or other unique identification
 - (iii) Birth date
 - (iv) Physician's name
 - (v) Date and time of collection
 - (vi) Source of specimen and manner of collection
 - (d) Patient's name and another unique identifier (i.e. birth date) are required upon

receipt. Specimen's submitted with only one identifier must be rejected.

2) IMPROPER SPECIMEN

- (a) The specimen has been improperly submitted. The full name of the patient or other unique identifier is missing from container/slide. The name on the specimen and the name on the order do not match.
- (b) Shared specimens are received with insufficient amount of specimen for cytologic preparation.
- (c) The specimen submitted is not in compliance with standard precautions, i.e., the container is leaking; the slides are broken or shattered beyond reasonable repair.
- (d) Specimen deterioration: the transport of fresh specimen is delayed, the specimen is not fixed properly, or the specimen is not stored properly.
- (e) The specimen is not received from a licensed source.
